ELIGIBILITY TO VOTE

A member shall be eligible to vote in the Election in terms of Article 12 of (New) Memorandum of Article of PAKSEA as under.

Article 12(a). Every member shall have one vote and shall have equal rights and privileges except as provided for in these Articles.

(b). Every member eligible to vote shall deposit with the Secretary General, the specimen signature card along with his/her photograph indicating his/her status in the firm, company or concern. The right to vote shall be allowed only to the proprietor, partner or the director of the member firm or company, or a person not below the rank of General Manager authorized by the Board of Directors of Public limited company or a Multinational company, as the case may be.

(c). Neither postal ballot nor proxy will be allowed.

(d). no member shall be entitled to vote at any meeting of Association unless all moneys due from him on account of subscription or otherwise have been paid to the Association by the due date.

(e). No member who has resigned or ceased to be a member or has been expelled from the Association shall be entitled to attend or vote at any meeting of the association.

(f). The Chairman or whosoever is presiding over a meeting shall, in the case of equality of votes, have a second or casting vote except in the matter of any election of the Association.

(g). a member shall be eligible to vote in election of the Association after completion of two year of membership provided the member fulfills the membership and the change of class of membership, if any, has been notified to the Secretary General with the approval of Executive Committee as the case may be at least three months prior to the announcement of election schedule.

CONDITIONS OF NOMINATION

In term of Article 24, 25, 27 (iv), (viii), (ix)

All present members elected under the TOO 1961 are eligible for nomination to Executive Committee.

Article 24. The tenure of the executive committee shall be two years subject of the following;

- I. Fifty per cent members of the Executive Committee shall retire every year.
- II. After the first election of the election of the Executive Committee under the trade Ordinance a draw shall be held to determine the fifty per cent members who shall retire after expiry of first year.

Article 25. On completion of the term the Chairman and Vice Chairman and the members of the Executive Committee shall not be eligible to contest election or co-option in any representative capacity in the Association for the next one year. Provided that the immediate past chairman shall be ex-officio member of the Executive Committee.

Provided further that this Article shall not apply to the office bearers and members of Executive Committee elected under the Trade Organisation Ordinance 1961.

Article 27 (iv). A candidate who desires to stand for election must be proposed by one member and seconded by another.

(viii). Two representatives of any one member shall not be eligible to stand for election.

(ix). The member who has not paid the subscription before the election takes place shall not be eligible to stand for election or to exercise his right of vote.

1. Every member having no outstanding dues in the Association is entitled to file nomination for any one post specified above.
2. The nomination forms pertaining to Lahore Area will be handed over to the Secretary in Lahore, who will then pass on the same to the Secretary General at Karachi by 24 August 2011.
5. Nomination(s) should be handed over to Secretary General by 5 pm on Wednesday 24th August 2011.
